DIRECTIONS FOR FILLING OUT REGISTRATION APPLICATION

Any Watusi animal may be registered if it meets all of the requirements for registration. The Association will process only those forms when properly completed and accompanied by the appropriate registration fee.

1. Check the appropriate box for the animal's sex.
2. Name of animal to be registered. The owner of the animal must name the animal, limiting the name to 24 letters, and no symbols will be accepted.
3. The holding brand (ownership brand) must also be branded on the animal, prior to making application and its location given on the application form (If owner uses a state recorded brand.)
4. Identification brand and/or tattoo numbers if used.
5. Indicate name of sire and his WWA number. Indicate sire and dam of sire if known.
6. Indicate name of dam and her WWA number if of unregistered, her breed type. Indicate sire and dam of dam if known.
7. Print name of breeder and address as it shall appear on the certificate of registration. The breeder is the person who owned the cow at the time of service. That person is the only one who can validate this application for registration.
8. Signature of breeder.
9. Date of application.
10. Check the appropriate boxes if the animal to be registered was a result of natural service, artificial insemination, embryo transfer, whether single, twin, or multiple, or, if the dam was serviced by multiple bulls, the DNA Parentage Certificate is on file.
11. Indicate month, day (if known) and year the animal was born.
12. When giving color description, begin with the most dominant color. The description should be brief and to the point.
13. Print name of owner and address as it shall appear on certificate of registration.
14. Signature of owner.
15. Date the animal was acquired by the new owner.
